

## 2023 Oases of Excellence Conference



Faculty from 11 states gather in Durham, North Carolina, for the Oases of Excellence Conference.

n September 8, 23 faculty from across the country met in Durham, North Carolina, for the 2023 Oases of Excellence Conference. The American Council of Trustees and Alumni (ACTA) hosted the day's program in partnership with the Civil Discourse Project at Duke University.

Campus centers earn ACTA's designation as an Oasis of Excellence by promoting rigorous academic study, a strong liberal arts curriculum, and viewpoint diversity. These faculty-led, donor-supported programs play a vital role in restoring the promise of higher education. See the full list of Oases of Excellence programs on ACTA's website.

In his opening remarks, Dr. Jed Atkins, director of the Civil Discourse Project, encouraged attendees to continue their good work to keep the study of the liberal arts alive and to expose students to the full range of intellectual viewpoints. He said, "Hope is the virtue that is seen clearest precisely in times of difficulty. It relies on agency over passivity to navigate challenging circumstances."

This year's gathering included several longtime ACTA friends, including Siri Terjesen, executive director of the Madden Center for Value Creation at Florida Atlantic University, who moderated a panel on entrepreneurship featuring Bruce Caldwell and Justin Heacock, both recent additions to the network. Dr. Caldwell, who leads the Center for the History of Political Economy at Duke University, remarked, "Constant vigilance is the cost of liberty. . . and the cost of keeping a center going."

The conversation was enriched by the perspectives of faculty from a diverse range of institutions, including small private universities and large public schools. Panelists and

## **ACTA Welcomes Three New Oases of Excellence**

## Madden Center for Value Creation, the Center for Great Books & Human Flourishing, and the Free and Open Societies Project

OASES of EXCELLENCE

Three more programs have joined ACTA's Oases of Excellence network, bringing the total to 90 centers. The directors of all three of the new centers attended this year's

Oases of Excellence Conference held in North Carolina. The Madden Center for Value Creation at Florida Atlantic University (FAU), the Center for Great Books & Human Flourishing at Faulker University, and the Free and Open Societies Project at North Carolina State University are all dedicated to promoting civic education and introducing students to the liberal arts in creative ways.

The Madden Center, founded and led by FAU College of Business Associate Dean Siri Terjesen, seeks to provide students with an intellectual foundation to create value in their communities and contribute to overall prosperity within our society through training in entrepreneurship and an understanding of the free market. Students who complete a seven-unit course receive a certificate in Value Creation. The Center for Great Books & Human Flourishing offers undergraduates the opportunity to engage with guestions of the good life and a flourishing society through student programming, speaker events, and fellowships. Now in its fourth year, it is led by Dr. Jason Jewell. The Free and Open Societies Project, directed by Andrew J. Taylor, promotes the discussion of foundational political ideas through lectures, undergraduate research grants, and courses like Public Choice and Political Institutions and The Classical Liberal Tradition.

ACTA is thrilled to welcome three new programs dedicated to rigorous study, quality pedagogy, and viewpoint diversity.



participants shared their challenges and successes in leading their programs and expressed a shared concern for restoring higher education and upholding the liberal arts. Conference panels included "Entrepreneurship, Economics, and the Liberal Arts," "Defending the Liberal Arts," "Workshop: Foundation Giving," and "Civics, Citizenship, and Civil Discourse."

George Lucas, former president of the International Society for Military Ethics and professor emeritus of ethics at the U.S. Naval Academy, delivered the keynote address. A philosopher and military technology expert, Dr. Lucas explored the implications of artificial intelligence, particularly large language models (LLMs), for the liberal arts. It is easier for students to rely on LLMs like ChatGPT to cheat on exams or essays than pursue a rigorous course of study. Liberal arts proponents need to rethink how to advocate for the enduring value of a strong liberal arts education; it is not simply the acquisition of skills, but the pursuit of being human. Al risks making the liberal arts appear permanently irrelevant when its rise really means that understanding human nature is more important than ever.

Christine Basil, associate professor in the Belmont Abbey Honors College, said the conference provided "very valuable time to look up from the everyday work and to get a feel for the bigger picture of higher ed and the obstacles to the good as well as the very real successes it contains."

## From the Bookshelf

## What is Philanthropy For? by Rhodri Davies

hodri Davies's 2023 book What Is Philanthropy For? provides a strong

historical account of philanthropy and incisively examines the tensions between philanthropy and related concepts of charity, justice, the state, democracy, and the market. In his treatment of each concept, he argues that we must approach complicated issues with intellectual humility, an informed perspective, and a capacity to live with nuance.

Mr. Davies covers a significant amount of ground in his survey, from the role of the church in philanthropy during the medieval period, to the main arguments behind tax breaks for charitable donations, to the increasingly blurred lines between businesses and nonprofits in philanthrocapitalism. The author skillfully weaves history into these ongoing debates, but those who are more interested in philanthropic practice may find the level of detail overwhelming.

The book's emphasis on understanding the events, funders, and politicians who shaped philanthropy as it is today helps us develop "a shared understanding of the choices that have been made and why, and that we are able to accept these choices or to challenge them in a

constructive way when needed." Without this historical perspective, Mr. Davies observes, "Too often debates about philanthropy collapse into polarized polemic that breeds only defensiveness and resentment and moves nothing forward." This is the author's central insight, and one that bears repeating.

Controversy often surrounds philanthropy as donors try to solve complex societal problems, but a solid grasp of the related concepts of charity, justice, the state, democracy, and the market can transform a frivolous and highly fraught argument into a fruitful discussion that makes the world slightly better, one gift at a time.
